Basics

This little book is concerned with those questions of typography that can be considered as belonging to the area of micro- or detail-typography.

While macrotypography – the typographic layout – is concerned with the format of the printed matter, with the size and position of the columns of type and illustrations, with the organization of the hierarchy of headings, subheadings and captions, detail typography is concerned with the individual components – letters, letterspacing, words, wordspacing, lines and linespacing, columns of text. These are the components that graphic or typographic designers like to neglect, as they fall outside the area that is normally regarded as 'creative'.

When reference is made in what follows to formal matters, this does not primarily refer to 'aesthetic' issues in the sense of personal aesthetic freedom or personal taste, but rather to those visible elements that enable the optimum reception of the text. As this is the aim of every piece of typography involving large amounts of text, a concern with formal elements becomes a concern with issues of legibility and readability. Thus, in detail typography, formal elements have little to do with personal preference.

There are many matters of detail typography which one can, in good conscience, resolve differently. The author would certainly not want this book to be regarded as an infallible catechism; rather, he counts on intelligent designers, who, in the spirit of this book, find appropriate solutions to the problems that arise in a given context, even though not all potential problems are dealt with in this text.

And there are texts in which all the details have been attended to – and yet they look so soporifically dull ...

The reading process

As experienced readers read, their eyes spring jerkily along the lines. These brief movements are known as saccades, and they alternate with fixed periods lasting 0.2–0.4 seconds. A line is perceived in a series of saccades, followed by a large saccade as the eye jumps back to the left to start the next line. Information is only absorbed during the fixed period. With average type size, as used for books, a saccade represents 5–10 letters, or about 1–2 words in English. A saccade may begin or end within a word. Of the up to 10 letters, only 3–4 are focused on sharply during the fixed period: the rest are perceived by the eye indistinctly and in their context. If the sense of the text is not clear, the eye jumps back, in regression saccades, to recheck what has already been 'read' [1].

The more experienced the reader, the shorter the fixed periods, and the bigger the saccades. If the saccades become too big, and the fixed periods too short – i.e. when one is reading too fast – the text must be guessed at. Here, at least with simple content, the redundancy of language makes comprehension easier. When Jan Tschichold said that it was 'a ridiculous error to think that one can read more quickly', he was obviously wrong, but even with intensive training it is only to a rather limited extent possible to increase one's speed of reading.

Word-images that have already been stored in a reader's visual memory are read more quickly than unfamiliar ones.

It is not yet clear to researchers which signals actually steer the movements of the eye. 'Independently of other external characteristics, the beginnings and ends of lines and of pieces of text are certainly such attributes. They determine the saccades at line changes. Within a line, however, the probability that a particular area will be fixed on is also determined by the sequence of the previous letters or words. In German texts, words with initial capitals are more frequently fixed on than words starting with lowercase letters. The form of the initial letter of a word may also have some slight influence on the probability of fixation. Even with experienced readers, long words cause multiple fixations.'

Apparently, not only the visual structure of the text plays a role in the eye's movements, but also its linguistic structure. 'From which The circles show points of fixation, on which the eye rests and looks

we may conclude that visual motor activity during reading is also controlled by the language areas of the brain.'

'The registering of eye movements can be used to objectively assess the legibility of a text. The same text will be read at differing speeds if systematic variations are made to the length of line, the size and shape of the type, and the contrast between the colour of the letters and their background. The size and frequency of the saccades depends on the form of the printed text. These variables, which can be measured objectively during the act of reading, correlate very well with the subjective impression of the greater or lesser legibility of a text These researchers confirm – not invariably, but surprisingly frequently – long-known rules of typography.

The letter

Our letters have grown slowly. Over time, they have adapted to various writing techniques and tools, to the materials to be written on, to production techniques and prevailing styles – less in their basic structure than in their details. Changes have mostly occurred unnoticed and over long periods.

The reception of everything written – including typography – takes place in two ways: firstly, in the act of reading itself, that is the conversion in the brain of the perceived succession of letters, and secondly as a (mostly unconscious) visual perception, that triggers associations with what has previously been seen and arouses feelings (see also 'The qualities of type', p. 54).

For this reason, and because typefaces have to meet various demands and fulfil various functions, a particular typeface cannot be described as generally good or bad, useful or useless. Typefaces for continuous text are subject to different criteria than typefaces for headlines on posters and in advertisements, for book jackets or for decorative purposes. Hard-to-read types, used skilfully and sparingly, can catch the attention of the reader or observer – can shock, provoke and thus encourage a closer look and the absorption of the information contained in the other words and pictures. Which typefaces to use, and how to use them for the multitude of advertising tasks that arise, are questions that designers have to answer on a case-by-case basis [2].

Readers of larger amounts of text, and book readers in particular, generally have a conservative attitude to type. They are not in favour of experiments with letters (or other elements of detail typography). These readers are not interested in letters as such. They do not want to look at 'beautiful' or 'interesting' letters, but to understand the meaning of the words they make up. Thus, it is not possible to make significant changes in the form of letters that are used for continuous text. In Stanley Morison's words, they 'will neither be very "different" nor very "jolly". It is not a good sign when a layman, reading a book, notices the shape of the letters, and talks of 'noble' or 'modern' letters. All the 'original' and 'noble' special types designed by German type designers (or type 'artists', as they were known) before and after the First World War – some of which were of remarkable quality – were

all too 'different', too 'excellent', and are today forgotten. Because the design of their types was too extravagant, and too closely reflected the fashion of the time, many private press and bibliophile editions now look old-fashioned and outmoded [3]. Many of the types designed in our own day will fare no better.

The same fate as befell the romantic, individualistic artists' types of the turn of the century also befell the apparently objective types from the Bauhaus and its adherents, and for the same reason. Here too, form came first – form as such, and not with regard to optimum readability; simplicity of letterform was the ultimate ambition. Furthermore, the type designers focused principally on the isolated individual letters, and less so on letters integrated into words [4]. Paul Renner's Futura has alone outlasted its period in its original freshness. Its success 'was due to the fact that on the one hand it responded to the spirit of the age, i.e. the need for clear "impersonal" forms, but on the other hand, did not deviate too far from familiar letter-

forms. (The excessively different alternative forms for some letters, based wholly on geometric constructions, failed to become established in practice)' [5].

It is almost impossible to define a good, timeless type as such. All that can be done is to point to a few particularly conspicuous characteristics.

The first of these is the familiarity already referred to; the eye of the reader must not be distracted by an unfamiliar form. Then, the letters in the alphabet must all have the same style, but at the same time, each letter must be clearly differentiated from all the others [6].

Like the Cyrillic and Greek alphabets, the roman alphabet also has both capitals and lowercase letters – that is, two fundamentally different forms of letter that must be combined together into a unity if a harmonious type is to result. While the capitals have retained in their basic structure the static, lapidary appearance of inscriptions, the lowercase, developed from them over hundreds of years, shows the dynamic characteristics of flowing handwritten forms, even in their typographic form [7].

The right proportions for capitals and lowercase are a further criterion for a familiar and easily readable book type. The capitals should not deviate too far from their archetype, the capitalis mo-

numentalis, the Roman inscriptional letter of the early imperial period [8]. The archetype for the lowercase is the scriptura humanistica, the book hand that was written in the fifteenth and sixteenth centuries, particularly in Italy. Its forms were punched and engraved in steel (with adjustments for technical reasons) by the punchcutters who worked for Sweynheim and Pannartz, Rusch, Jenson, Aldus and others, and thus found their way into book printing [9].

Also important for a book type that is agreeable to read is the proper relationship between capitals and lowercase, in terms of both size and weight. (This is particularly true of German texts, with their (too) many capitals.) So as not to disrupt the overall appearance of a typeface, the capitals should be somewhat lower than the lowercase ascenders [9, 10].

From the work done by the French ophthalmologist Emile Javal in 1878, we know that the eye does not always need to view a whole letter to recognize the individual forms of the roman lowercase: the upper half of the letter is sufficient [11]. Why this is so remains unclear. (It is not simply the case that the upper half of the x-height and the ascenders is more differentiated than the lower half of the x-height and the descenders; the lower halves of a, g, p, q are more strongly differentiated, even in sanserif faces, and those of o, s, v, w, y and z at least equally so.) At all events, we need to take account of this insight. It is reinforced by an experiment by Brian Coe [12].

If the legibility of a typeface did depend solely on differentiation in the design of the upper half of the x-height, this would put most sanserif faces, and particularly those with the simple form of a, at a disadvantage against classic book types [13].

Like all two-dimensional shapes perceived by the eye, letters too are subject to the laws of optics. The decisive element in assessing their formal qualities is thus not any kind of measuring instrument, but the healthy human eye. So the following points, which need to be taken into account in designing type, are better described as optical facts, rather than optical illusions:

- 1. For a given height, a circle and a triangle appear smaller than a square. For them to seem to be the same height, they must extend slightly beyond the top and bottom lines [14].
- 2. The mathematically equal horizontal division of an area produces an upper half that appears larger than the lower half. To produce two halves of apparently equal size, the dividing line must lie above the mathematical centre, in what is known as the optical centre [15].
- 3. For a given weight of line, a horizontal line appears heavier than a vertical line. To achieve optically balanced verticals and horizontals, which appear to be of the same weight, the horizontal must be somewhat narrower. This applies not only to straight lines but also to curves, which must indeed be somewhat broader at the broadest horizontal point than the corresponding verticals [16]. For optical reasons, right-leaning diagonals must also be somewhat broader, and left-leaning diagonals somewhat narrower than the verticals. Nor are all verticals of equal length equally wide: the more horizontal connections, the narrower the vertical.
- 4. Where curves intersect with straight lines or with other curves, or where two diagonals meet, lumps will occur, which, unless corrected, will disfigure the letter and make the composition appear blobby [17; see also 4].
- 5. Small sizes of type need to be proportionally wider than larger sizes. This is an optical requirement that is essential for optimum readability. (We can see this with our own handwriting: the larger the writing, the narrower the individual letters, and vice versa.) This was taken into account by the early punchcutters.

Although the Multiple Master fonts that addressed this problem did not meet with the success expected of them, they did show the way. OpenType fonts already offer possibilities that go beyond those of MM fonts. They should make it possible, in future, for all characters in a typeface to have the right proportions, weight and letterspacing for the size of type. In addition to optical margin adjustments at both ends of the line, further refinements are envisaged, such as variable kerning. This would enable pairs of letters to be spaced somewhat more tightly or loosely – depending on the amount of space available in the line – and also the counters of letters to be inconspicuously adjusted depending on the available space (which Gutenberg practised).

The aspects mentioned under 4 and 5 – the formation of lumps and the inadequacy of merely mechanical enlargement or reduction of a typeface – are related to objective and subjective 'radiation'.

Finally, some results of research into the relative legibility of individual letters can be mentioned. The first scientific analyses were published in 1885, with personal observations and subjective impressions already found in 1825. Tinker provides a summary of the results and some conclusions from them:

- Capital A and L are particularly legible, B and Q particularly difficult to discern. B is often confused with R, G with C and O, Q with O, M with W.
- In the lowercase, d, m, p, q are easily legible, j, r, v, x, y averagely legible, and c, e, I, n, l difficult to discern. Lowercase c is often confused with e, I with j, n with a, and l with j.
- Of all the factors governing the relative legibility of lowercase letters, the most important is emphasis on their differentiating characteristics.

Other criteria affecting the appearance and legibility of individual letters are covered in the next chapter, as their effect only becomes apparent within the word.

Something more needs to be said about italic types. Their most obvious characteristic, at first glance, is their slope. In fact, this is only a secondary characteristic. The original written form of our italic types appeared in Florence at the beginning of the fifteenth century, in the same place and at about the same time as the scriptura humanistica. This correspondence hand, which later became known as cancellaresca corsiva, differs structurally from the humanistica in important ways. On average, there are fewer individual penstrokes, the pen is held at a steeper angle, and the individual letters tend to link together; for a given size, it needs less space as it has leaner proportions. Because for these reasons it can be written relatively quickly, in the hands of many scribes – but by no means all – it acquires a more or less pronounced slope to the right [19].

The first to use italic types in book printing was the Venetian humanist, printer and publisher Aldus Manutius, in 1501, for his 'pocketbook' editions of classical authors [20]. While Aldus and the other printers of the first half of the sixteenth century regarded italic as an independent book type, later on, from the middle of the sixteenth

century to the present day, it was increasingly used mainly for emphasis. As such, it remains the most elegant and yet clearest option for emphasizing individual words or whole pieces of text, whether simply on account of its structural difference with the text type, or, in addition, because of its differing tonal value. (For other emphasis options, see 'Emphasis', p. 44.)

Not till the nineteenth century did 'false' italics occur, under the influence of drawn lithographic lettering. Of all the characteristics of true italics, they have preserved only the secondary characteristic of the slope, but not their fundamental structure [21, 22].

Today, it is possible to 'italicize' a type; that is, to electronically slope an existing roman type. The results are unsatisfactory, as there is no way of taking account of optical considerations. If a typeface lacks an italic, and there is really no alternative to 'italicizing' the roman, the slope should not be steeper than 10°, otherwise the distortions will be too great.

The word

Given that an adult reader's eye registers not individual letters but whole words, or parts of them, it is not surprising that words play a particularly important role in the reading process. With an easily readable typeface the individual letters are always designed with regard to their impact as parts of a word. While being clearly differentiated, they must be capable of fitting together as harmoniously as possible into whole words.

Large amounts of text are generally set in lowercase letters, with capitals at the start of sentences and of some individual words. The x-height, ascenders and descenders of our lowercase letters produce characteristic word-forms, which are further differentiated by accents, the dot on the i, the particular height of t, and of course by the varying contours of each individual letter.

Text set entirely in capitals, by contrast, simply produces patterns of more or less long rectangles. Text in capitals is particularly difficult to read and needs a large amount of space [23, 24].

Clearly differentiated design of the ascenders and descenders is therefore an important requirement. It is not achieved only by making them long enough, but also by the character of the design, for example in the serifs.

The hard-to-read texts that we are sometimes confronted with are often the result of inadequate letterspacing. With any printed matter, the printed area interacts with the unprinted area. This applies equally for the individual line, for the individual words and for the individual letters. In the same way that the whole page should have a consistent, even, but not boring grey tonality, both the lines and the words must also have a consistent grey tonality. (As we have already seen, this is a matter that the type designer needs to take into account in designing the individual letters.) Spotty, uneven words, lines and pages result when the space between the letters is wrong – too great, too little or uneven.

The space between letters is a function of their interior spaces, or counters. The smaller the counter, the smaller the space between letters, and vice versa. This applies not only to the roman alphabet, including blackletter and italic, but also for Greek and Cyrillic, and for all written, drawn and typographic letters [25].

Letterspacing that appears lighter than the median lightness of the counters of the letters concerned produces, in lowercase setting, word-images that appear to fall apart; too tight letterspacing produces blotchy, uneven words [26].

Exceptions: certain types – narrow sanserifs and narrow italics – can be difficult to read in small sizes. In such cases a few additional units of letterspacing can improve their readability. The amount of spacing must be selected on a case-by-case basis, depending on the design and size of the typeface [27].

For the lowercase, there is in theory a right spacing for any given size of type. (At least, the variables concerned are within an extremely narrow range.)

Things are somewhat less straightforward with capitals. Here, the starting point is a minimum space, that can be increased more or less, depending on the situation. The minimum space is determined by the lightness of the biggest counters (C, D, G, O, Q): if any of these letters causes a 'hole' to appear in the word, the spacing is too tight [28].

The spacing may, though, be considerably wider. But this requires appropriate surroundings. Widely spaced capitals require a great deal of space around them, and particularly above and below.

If they are to be readable, capitals require not only to be spaced: the spacing must also be even (which also applies, under different circumstances, to the lowercase). The spacing is even when the spaces appear optically equal.

When this matter is discussed in the professional literature and on courses, reference is often made to the concept of equal areas [29].

However, precisely this example makes it immediately clear that – for example – the space between O and L is greater in area than that between R and T. And what about the spaces between L and W, and T and H? Where does the space between letters begin, and where does the space surrounding a letter itself end? Although the areas

them. The light coming from above is more effective than that coming from below. This means that the n of a sanserif typeface must be somewhat wider than the u of the same typeface, if both letters are to appear equally wide. Similarly, the space between I and A must be smaller than the space between I and V (given that A and V have the same angle). This phenomenon is not explicable in terms of equal areas, but it is in terms of the need for equal light [31].

Non-metal-based composition systems have made it possible not only to increase, but also to reduce the space between letters [26]. While with metal type it was impossible or technically problematic to reduce the gaps that appear between some capitals and the following lowercase letters, this is no longer a problem. It is done by 'kerning'. So, what is this?

As with metal type, in digitized type each letter also has a standard width. The letter itself has an additional space left and right, which are so determined that the letter will fit well in most combinations – not too close to the previous letter, nor too far away from the next one. These spaces are known as the sidebearings [32].



Although the text of the Scottish catalogue was composed without using 'tracking', that is, with 'normal' letterspacing, the letters are too tightly spaced (see, e.g., the sequence illi in brilliant). With almost identical interlinear spacing, the type is too large, which makes it harder to follow the lines. For these reasons, the text is less inviting than the version above. This has nothing to do with photosetting as such; rather it is the result of the hyphenation and justification values being chosen carelessly, according to prevailing fashion.

That the overall impression of a piece of printed matter always depends on the typographical details can be seen from the following: in the Scottish version, the drop initial is too big; the lines in capitals are too tightly set, not optically spaced, and have too little interlinear space. Although the whole layout and (apparently) the details too were taken over from the Zurich catalogue, the result is unsatisfactory. (That the Scottish catalogue is 8 mm shorter but the same width, so that the type area is quite wrongly placed on the page, is part of the same story.)



lowercase letters. This is a survival from the early days of non-metal composition when, in the sheer euphoria of being able to justify more tightly, much photosetting was far too tightly spaced. Capitals have bigger counters than their lowercase, and require an appropriate amount of space [33].

Many typefaces, and particularly italics, also need additional kerning for the lowercase. Generally speaking, individual letters

should not touch. A small 'hole' between two letters is less bad than letters that collide with each other. But here too, there may be exceptions – decisions require common sense and a trained eye [34].

It is possible to correct an existing kerning table, or to supplement it with additional combinations, but care is needed: the corrections should not be perceptible, nor should they create any collisions with floating accents. A serious set of kerning values can only apply to a single language, for each language has its own critical letter combinations.

Another aspect of the word is ligatures. These are generally composed of two or three joined-together letters. Standard ligatures include fi, fl, ff, ffi and ffl [35].

The line

The line is the third unit of detail typography, after the letter and the word. Wordspaces, the spaces before and after punctuation, as well as line length, are important matters for typographers. While all the issues that concern letters and words apply for all forms of continuous text, considerations about the line must also take account of the nature of the piece of typography in question.

This applies particularly to the length of the line, or measure, as it is also known. An academic work, which needs to include wide mathematical formulas, table or diagrams, will, unless double-column setting is an option, naturally have longer lines than a novel, a reference work, a leisure magazine for entertainment, or a daily paper. Lines that are either too short or too long are tiring, and thus detract from readability.

This is not a real problem with the often (too) short lines of reference works, in that they seldom require the reading of large amounts of text. Typographers recommend an optimum of between 50 and 60 or between 60 and 70 characters per line. Tinker claims that a 10 pt type with 2 pt interlinear spacing is equally readable at measures between 14 and 31 picas (about 6 to 13 cm), but also notes that 'reader preferences quite definitely favor moderate line widths. Relatively long and very short line widths are disliked. In general, printing practice seems to be adjusted to the desires of the average reader with regard to line width.'

It appears that, here too, there is a remarkable discrepancy between optical legibility and being inviting to read (see p. 54 below).

The relative legibility of a line depends not only on its length, but also on the right wordspacing and the type of composition.

There is no question but that wordspaces may not be too large, or that the line must appear to be an even, well-balanced whole. What applies to letterspaces also applies to wordspaces: they too are a function of the counters of the individual letters: the smaller these are, the smaller the wordspaces; the larger the counters, the larger the wordspaces [36].

The generally applicable rule for wordspacing is: as much as necessary, as little as possible. A clear but not excessive space will normally be around a quarter of the notional body size, e.g. 2.5 points

for 10 pt type. But here too, ultimately, the critical eye must decide [37, 38]. Smaller sizes of type require proportionally more space, and larger sizes proportionally less [39].

Justified composition is typesetting in which all the lines are spaced to be of equal length. The space that would otherwise be left over at the end of the line is distributed between the words: this is known as justifying the lines. If there is a good deal of space left over at the end of the line, the wordspaces in the line can be reduced to get another word, or at least another syllable, into the line. If this is not possible, it becomes necessary to increase the wordspacing until the line is filled out ('driving it out' is the trade expression). If the measure is wide enough, neither of these operations should be noticeable; good justified composition has an even, neutral appearance. For English composition, a line length of between 60 and 70 characters (as in this book) represents a reasonable compromise between the optimum number of characters in the line and evenly-spaced composition. Other values apply for other languages: words are longer in German than in English, French or Italian, for example, so German may require longer lines.

If the measure is too narrow – with less than around 50 characters per line – even wordspacing becomes difficult, if not impossible. The wordspaces become obviously uneven and large 'holes' appear. These problems can be avoided with unjustified or 'ragged' setting, where the wordspaces are all the same, and the right-hand end of the line varies in length.

Unjustified setting is not restricted to narrow measures, but can also be used for measures that would be suited for justified setting. In such cases, it will be selected for aesthetic, design considerations: the even wordspacing within the lines makes the text appear more regular, but at the same time, the irregular right-hand margin makes it appear more lively.

Unjustified setting can be produced in two ways:

- 1. Unjustified setting with no word breaks and no further attention [40a]. Depending on the nature of the work, this rather crude, unpolished form may be entirely appropriate.
- 2. Unjustified setting with reasonable word breaks and an appropriate 'hyphenation zone' (the distance between the longest and the

shortest lines). This generally has about the same number of characters in the line, or not many fewer, as justified setting.

The 'hyphenation zone' should not be too wide. Wherever possible, irregular rhythms, 'staircases', 'holes' and single words standing at the end of lines should be avoided [40a], as should bad word breaks. Unjustified setting with a wide hyphenation zone (with a 'hard rag') looks uneven and unsettled, even if the rhythm of the long and short lines is regular; then, it looks more like poetry than it is entitled to. In unjustified setting with a narrow hyphenation zone, the text is given a 'soft rag' [40b].

Perfect unjustified setting is very demanding and difficult to achieve, and is thus rarely encountered.

Many rules concerning the space before or after certain capital letters or punctuation marks that were once observed as a matter of course in good typography are widely ignored today. They are, however, important not only for the even appearance of the composition, but also for the easy understanding of the text. Depending on the typeface, the appropriate units must be added or subtracted. Thus:; ?! and 'should be separated from the final letter of the preceding word by a clear space. Similarly, brackets, quotation marks, superior figures and asterisks should not stand too close to the preceding or following letters. If the type manufacturer has not taken account of this in the kerning program, manual intervention will be required in such cases [41].

In the same way that the wordspaces must be somewhat reduced after letters with too much 'body' (A T V W and Y), they must also be reduced after abbreviation points (fig. Prof. no. etc.) [42].

An unfortunate usage that is often encountered is too little space between the initials of forenames, followed by excessive space between the initials and the surname [43]. And correct use should be made of all the other punctuation marks; they are not as unimportant as their insignificant appearance might suggest [44, 45].

The ellipsis (...) is a sign of its own. It indicates omissions, and can be replaced by three full points (...). If this is done, they must be spaced. Which option is used will depend on the typeface in question [46].

Dashes are often used incorrectly. There is a distinction between the hyphen (-) and the dash, which can also be a minus sign. This is either the em dash (-), which extends over the whole width of the notional body of type, or the so-called en dash (-), which is actually seldom exactly half the body width. The hyphen should not be used for functions for which a dash is reserved [47-50].

The diagonal solidus stroke (/) is often set without space between two words, which can result in nonsensical situations [51].

If measurements are given in running text, the multiplication sign (\times) , while correct in itself, is too obtrusive, and should accordingly be replaced by the x of the typeface being used [52]. Both British and American usage has traditionally favoured double quotation marks

Seven is a number, but 7 is a numeral. The terms 'number' and 'numeral' are often confused. A number stands for a quantitative concept; a numeral is a graphic sign that represents a number. As numerals are usually part of any more complex text setting, they are dealt with in this chapter. They are referred to here, as is normal in typography, as 'figures'.

Western civilization is familiar with the Roman numerals, represented by letters (IVXLCDM), and the arabic numerals 0 to 9.

With arabic numerals, there are lining figures, non-lining figures, and also small cap figures, superiors and inferiors, and fractions.

Lining figures are all the same height: usually the same as the capitals or slightly less. They are normally set on a constant (en) body, so they can be used as tabular figures. Non-lining figures, by contrast, have individual widths. Increasingly typefaces are being provided with individual and constant widths for either, or indeed both, the lining or the non-lining figures [55].

Small cap figures, i.e. figures with the same height as the small caps, are rarely found. If available, they should be used; if not, non-lining figures should be used with small caps [56].

To prevent large numbers becoming difficult to read, the numerals are grouped in threes, separated by commas, starting from the back. In scientific publications, the commas may be replaced with spaces [57].

Superior figures should be separated from the preceding letter by a small but unmistakable space [see also 41]. The same applies to inferior figures, which should lie somewhat below the line. Both lining and non-lining figures are suitable for use as superiors and inferiors, depending on the typeface used. As they are sometimes too small, or too large, or are not correctly placed with regard to the baseline, it may be necessary to change the default settings to arrive at a satisfactory result [58].

Both the lining and the non-lining figure 1 are often placed on a too wide body, as in the Minion typeface used in this book, which results in undesirable spaces, and from time to time requires manual correction [59].

Fractions can be set with lining or non-lining figures: here too, the decision should be based on the typeface used, or the specific typographical situation. Some typefaces have special fraction figures. They are already correctly positioned, are stronger, as they have not been reduced in size, and thus fit much better into the overall composition. Their diagonals are also somewhat more acutely angled than the ordinary solidus stroke, which should not be used in their place [60].

As with words in capitals, lining figures are over-obtrusive in running text, and create a restless appearance. They should be restricted to tabular work, and non-lining figures used wherever possible in continuous text. Lining figures are also often not ideally justified, and require additional kerning or individual attention [61].

Many sanserifs have only lining figures. And there are a very few typefaces, such as Monotype Bell or Microsoft Georgia, that do not distinguish between lining and non-lining figures. Their 'standard figures' are so designed that they are only a little taller than the x-height, and thus do not disturb the flow of the text.

Emphasis

The classic means of giving emphasis to a word or phrase in continuous text is to set it in italic. Common experience suggests that italic is somewhat slower to read than roman type, and its use in large quantities is not appreciated by readers. Used sparingly, it has the advantage of attracting the reader's attention without disturbing the flow of the text.

The same is true of small caps. These are capitals whose optical height is the same as the x-height of the lowercase. They cannot be substituted by a smaller size of capitals, as these will look too pale, on account of their reduction in size. The weight of true small caps is the same as that of their uppercase and lowercase, but their proportions are broader than those of the capitals [62–64]. Whether or not small caps should be spaced is sometimes disputed; in the author's opinion, this will depend on the design of the type. At all events, readability is generally noticeably improved when small caps are slightly, and more or less evenly spaced. When text is set in small caps, words that begin with a capital letter need also here to begin with a full capital.

Other forms of emphasis – text set in capitals, the semi-bold or bold versions of the text type, underlining, a larger size of type, a different typeface, the use of a second colour or tones – produce a restless effect, and hinder linear reading. Such forms of emphasis can, however, be not only appropriate but necessary in reference works and schoolbooks, and also have a refreshing effect in experimental books.

Linespacing, the column

The readability of a text is influenced not only by the choice of typeface, type size, correct or incorrect letter- and wordspacing, and the length of line, but also by the linespacing or interlinear space, often termed 'leading'. Tinker points to the interdependence of linespacing, type size, and length of line, and emphasizes the great influence that the space between the lines has on readability.

The longer the line, the more linespacing it needs, for a given typeface and type size. Equally, lighter typefaces – generally those with large counters – need more linespacing than darker ones. The internal form of the letters thus influences not only the letter- and wordspacing, but also the linespacing. For typographers, the linespacing is an important means for changing the 'colour', the grey tone of a piece of composition [66].

A question that arises in connection with justified text is that of 'optical margin alignment'. This is less important with smaller type sizes than with larger sizes, but should be applied whenever technically possible; the composition appears quieter, even in small sizes [67].

There is an old compositor's rule that there should never be more than three successive word-breaks under each other at the ends of lines. But if the only way to obey this rule were to remake the page with large gaps in one or more lines, this would be worse for both the appearance and the readability of the text than four or even five successive word-breaks.

Vertical 'rivers' of white space occur on a page when the wordspaces in several lines fall exactly, or almost exactly, under one another. As they disturb the flow of the text, the page make-up should be adjusted to avoid them.

It may be asked whether this is the place to deal with the matter of indenting the first line of a paragraph, or whether this rather belongs to considerations about the layout, which do not concern us here. As Tschichold repeatedly and convincingly stipulated, indenting is essential to the comfortable reading of long texts, and so it is mentioned here. The use of line spaces to separate paragraphs breaks up the page, requires too much space, and creates problems when a paragraph ends at the bottom of a page. In every case, indents are the only certain indicators of a new paragraph [68].

In the same way that the design and size of the type, the length of the line, the linespacing, and the style of the setting all determine the overall appearance of the composition, this too – the type area, the sum of all the lines – also has an effect on all the other components of typography, and on the proportions of the margins in particular: in typography, details can never be considered in isolation. However, to move on to consider issues concerning the position of the type area on the page would be to move away from the main focus of this book – detail typography.

The qualities of type

All the well-known and frequently used typefaces are equally legible. And much the same is true of their semi-bold versions; sanserifs too are more or less equally legible. Tinker, who, among others, reached this conclusion, does however mention that his respondents found the sanserif he used (Kabel Light) to be unattractive. Once again, we encounter the phenomenon that typefaces – regardless of their optical legibility – trigger particular feelings on the part of readers simply through their appearance, and can have a positive or negative impact. This seems to be pragmatic evidence to show that, over and above their primary and essential task of acting as a visual means of transport for language, typefaces are also able to communicate atmosphere.

In this context, Spencer mentions analyses by Ovink and Zachrisson that reinforce this assumption. However, on the basis of an analysis of advertisements over a period of 50 years, Spencer believes 'that findings of congeniality may have little temporal stability, and such an examination supports Warde's view, that the choice of an appropriate typeface is a subconscious act, the effect of which is ephemeral. We may also reflect that sanserif letterforms which have been much used in this century to express the notion of "modernity" were first revived in the eighteenth century because of their associations with rugged antiquity.'

In Kapr's opinion: 'The choice of typeface is naturally decisive for the interpretation of a text and its content. It is also permissible to interpret a text in various ways, much as an opera or a piece of music will be differently interpreted by different artists. But an artist working thus, with an existing work, must take care to reflect the spirit of the work; he may not work against it.'

Willberg reproduces the poem 'Bildhauerisches' by Christian Morgenstern from five different editions, and points to the 'interaction of text and type (and typographic design, for type size, arrangement and emphasis all have their effect)'. After analysing the five versions, he concludes that 'the poem can be read in all five versions. contributes its own tone to the overall music, either constructively or negatively. It also becomes apparent that harmony is indispensable. The conclusion must be that good typographers are right to give serious consideration to which typeface they choose for which text.'

When Willberg remarks (even if only in parentheses) that it is not the typeface alone, but also the typographic design – type size, arrangement, emphasis – that is responsible for the overall atmosphere or impression, he touches, in my view, on a key point.

The impression created by any one typeface can only be assessed when all the typefaces concerned are used to set the same text, in the same size, to the same measure, with the same linespacing, and are printed by the same method, with the same ink and inking, on the same paper, with the same margins.

Any change to any one of these elements changes the impression created by the type, for they are all interrelated [71,72]. In a book, for instance, the individual elements are also more or less closely related to its extent and to its stability or flexibility, and thus to the way it is bound and the binding materials – that is, to its haptic nature, its physicality.

A theoretically less attractive typeface can, through the proper choice and skilful deployment of all the other elements, be so enhanced that, as part of a typographic whole, it hits the right note. For typographers, analyses of the impression created by typefaces are thus often purely theoretical: they neglect the sheer complexity of typographic practice. They also harbour the danger that their results may incline people to apply prescribed solutions. This is something that creative typographers guard against.
